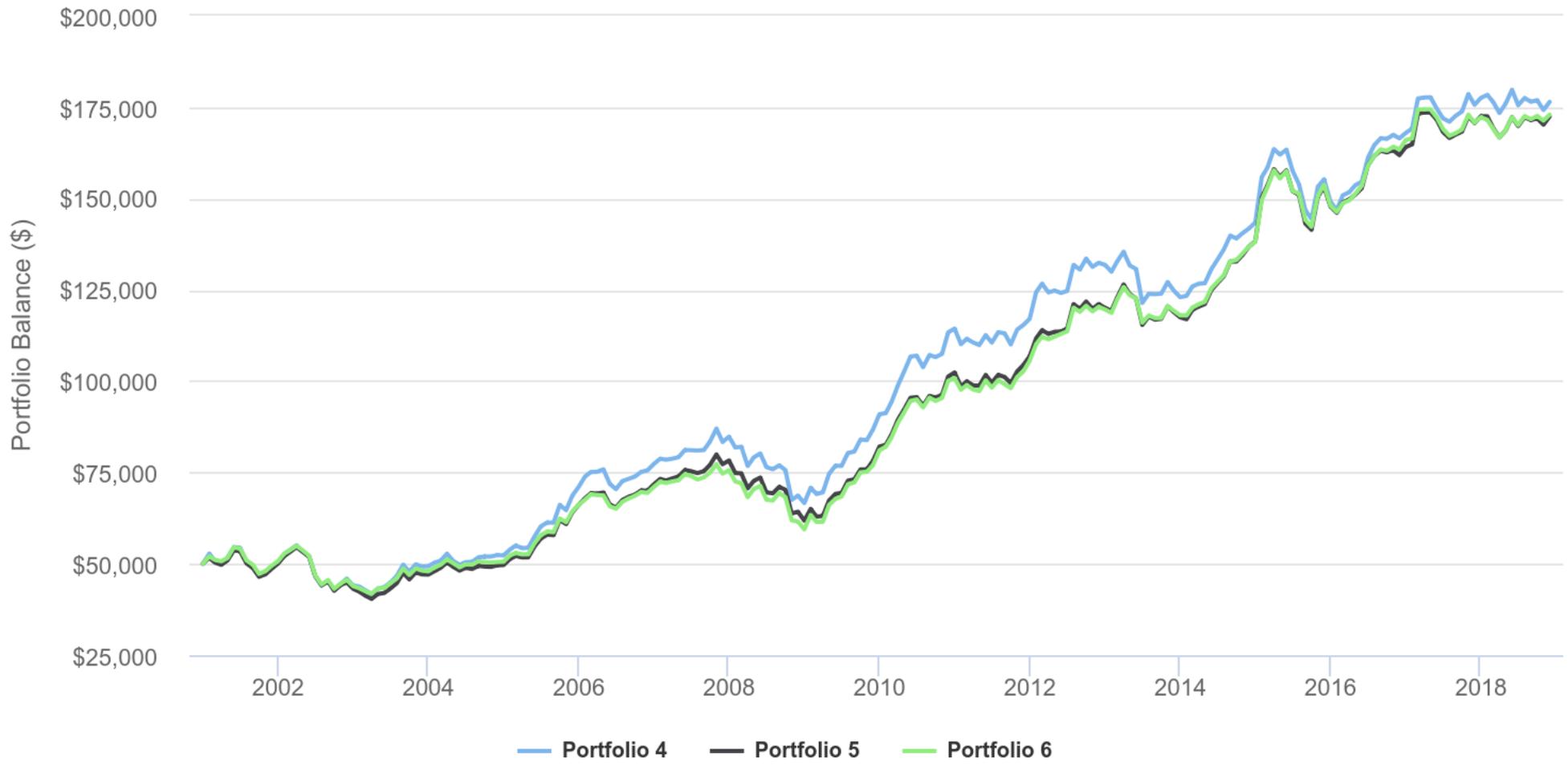

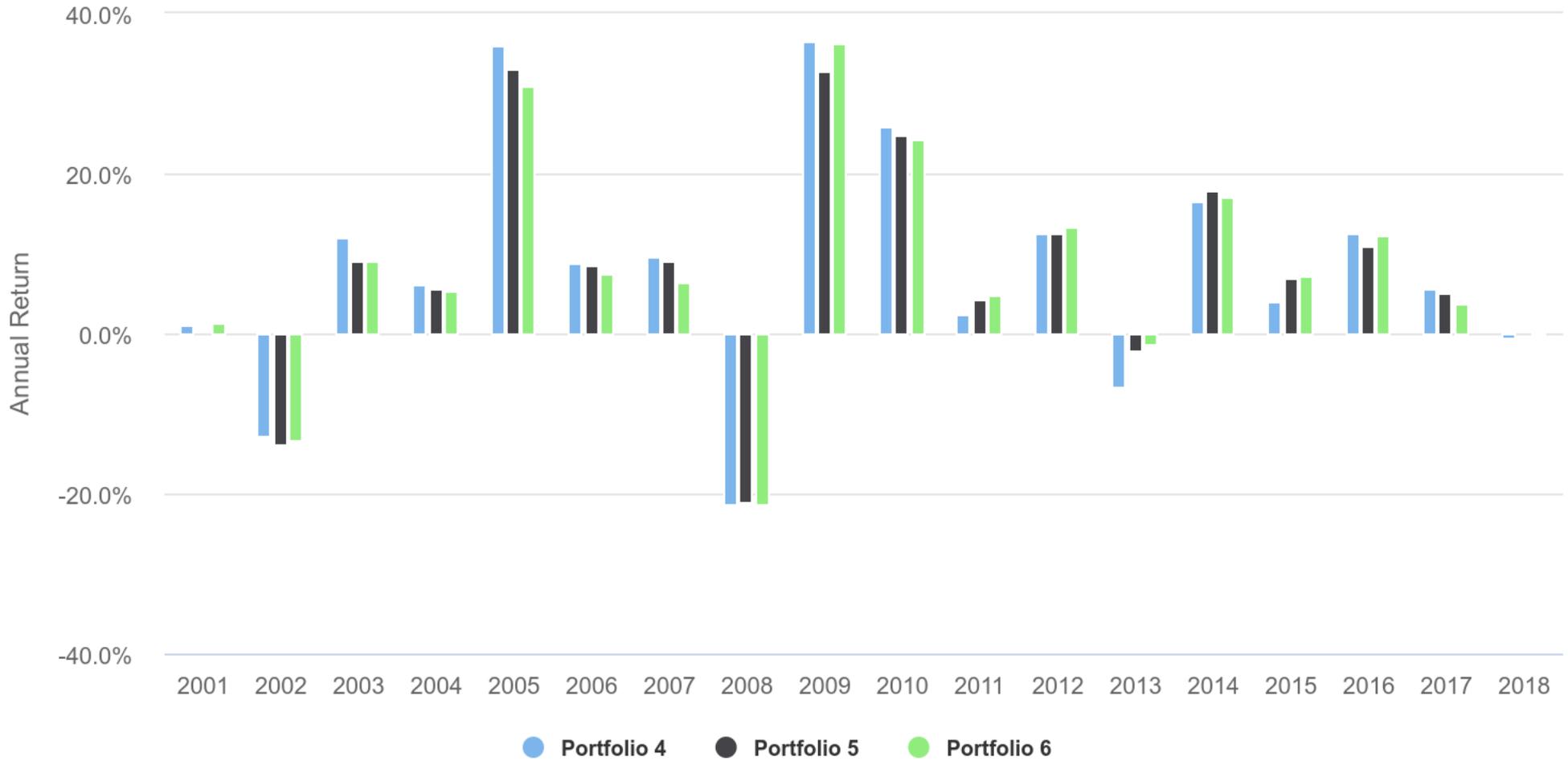

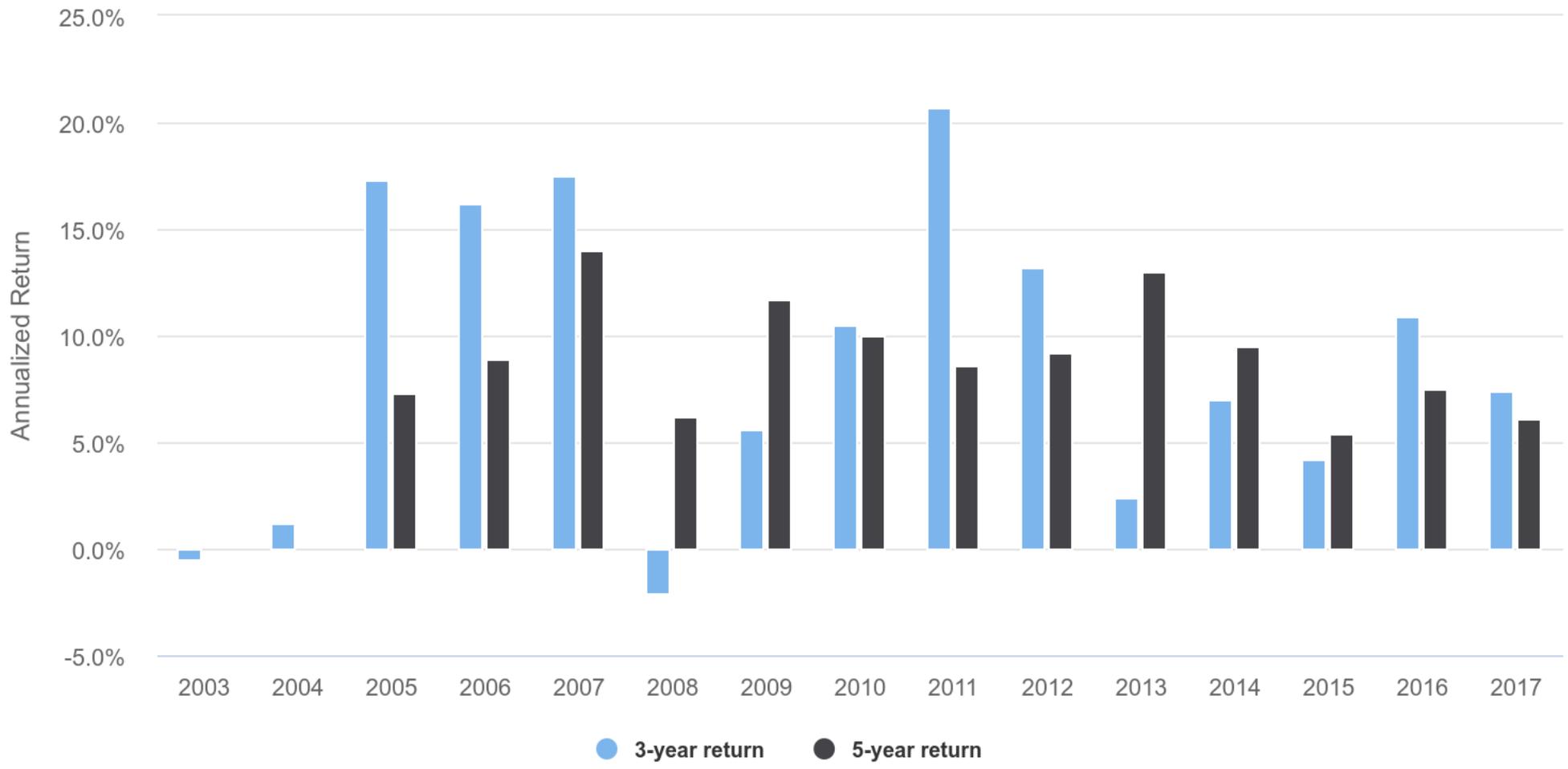

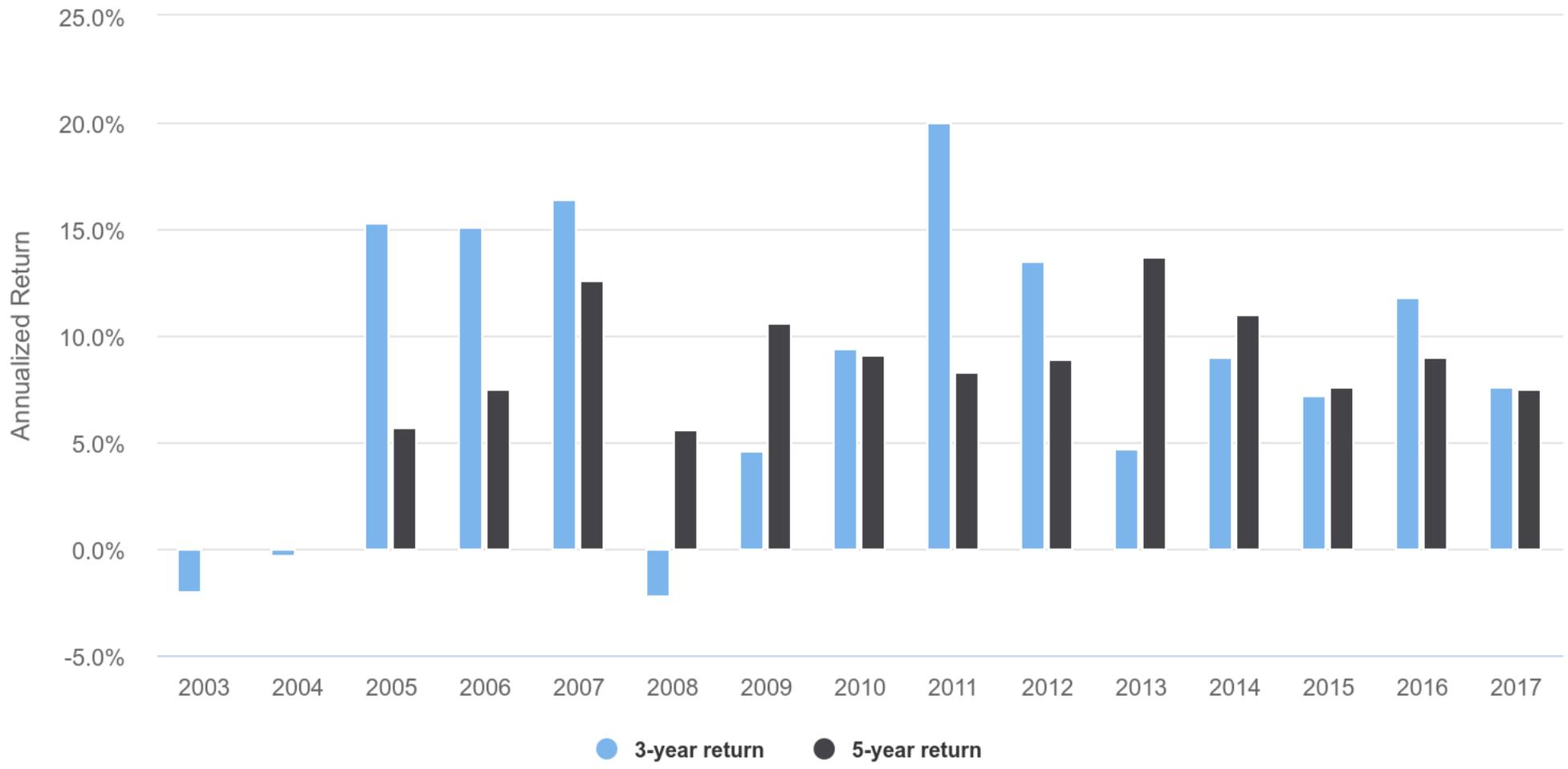

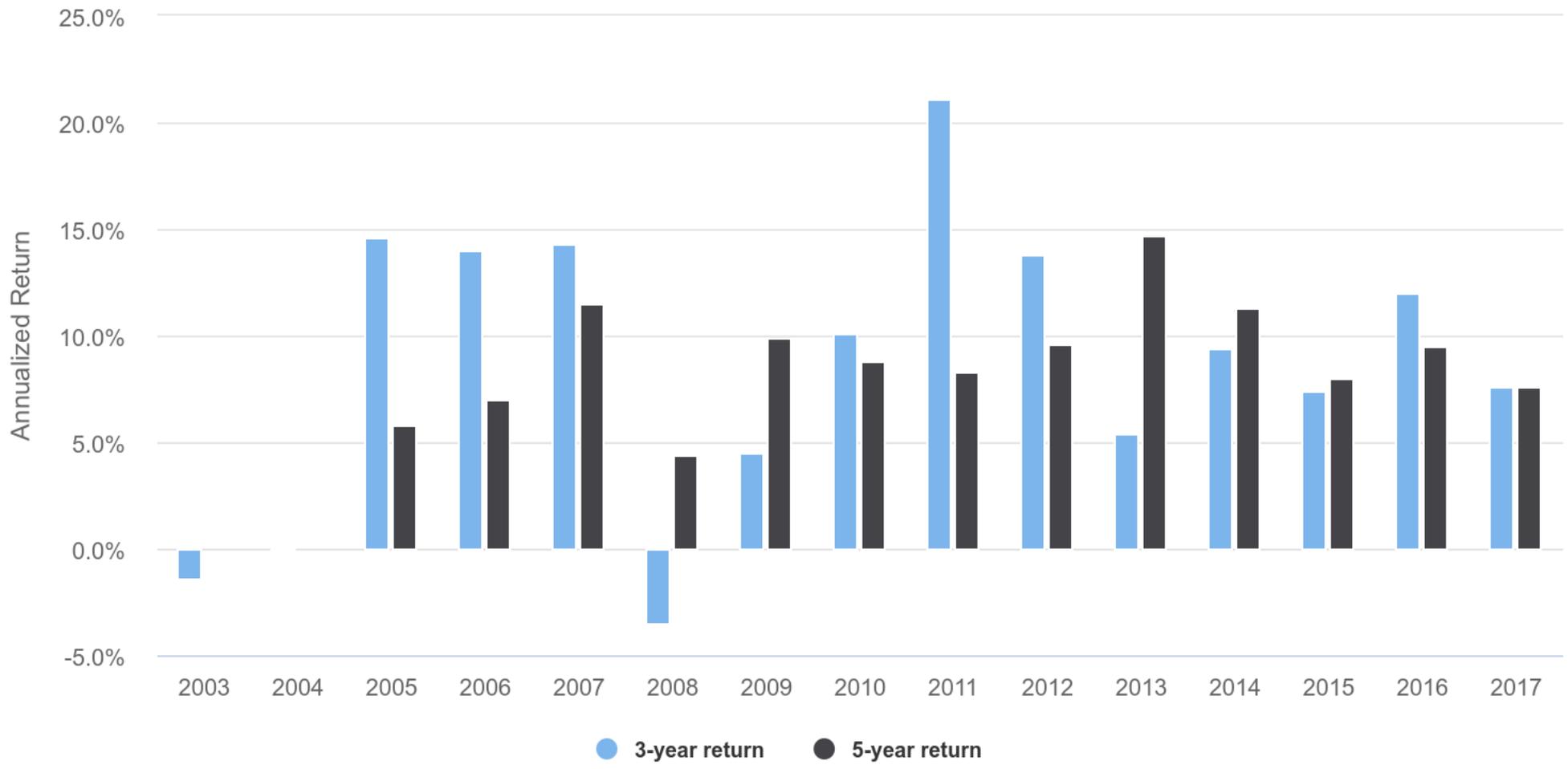
Portfolio 4 Rolling Returns
